# MasterWorks of NM Show Eligibility

**Age:** Living artists over the age of 18.

**Residency:** Must be a resident of New Mexico.

**Membership:** See each Organization's requirements.

**Entries:** Artists may enter all Categories. Entry for each Category requires a separate online submission.

Read each Organization's procedures carefully - they may vary!

- All works must be original.
- All works must be for sale.
- No copies, diptychs or other multiples, photography or computer generated work.
- Entries must have been completed within the last 2 years.
- Work cannot have appeared in a previous MasterWorks show.
- Entries cannot have been produced as part of a class instruction.

## STANDARD FINE ART DIVISION GENERAL REQUIREMENTS

*Read This Section First! Go to appropriate medium's category for specific information before submitting your entry.*

**Entries:** Maximum of 3 digital entries may be submitted in each Category. Maximum of 2 pieces can be accepted in each Category.

**Entry Fees:** A non-refundable fee of \$15 per painting, paid to Category's sponsoring Organization. (See Society's instructions).

**Entry Deadline:** All digital entries, paperwork and fees must be received by 5pm on Saturday, January 27, 2018.

**Entry Submission Procedures:** If you have entries created in different mediums, you must enter them in the appropriate category with the sponsoring society. Determine which society to submit to based on medium used to create painting, then follow their specific requirements on page 3. Be sure to have properly prepared image files, all information and a credit card ready.

**Entry Confirmation:** You may receive email confirmation that your entries were received.

**Jury Notification:** All artists will be emailed by Saturday, February 17, 2018 to notify them of acceptance/non-acceptance. For additional notification by US Mail, please provide a #10 self-addressed stamped envelope, with 2 first class stamps, to sponsoring society's Filemaster (see next page). *No certified mail accepted.*

**Refusal of Work:** MasterWorks has the right to refuse any work which fails to meet entry and eligibility requirements or work deemed inappropriate for public viewing.

**Availability of Painting:** If an accepted painting is unavailable for the show or does not meet show requirements, the artist will be prohibited from entering that medium the following year. Both unavailable and presold works require a 25% donation of the price on the entry form submitted to the medium sponsor.

**Sales:** A 25% donation will be collected by the sponsoring society of each medium. MasterWorks will handle all sales and will collect the gross receipts tax. Prices listed on entry form are final. Any shipping charges will be paid by the purchaser.

**Image Size Limitation:** 80 sq. inches minimum image size.

**Frame Size Limitation:** 72" high; 48" wide are Maximum outside frame dimensions.

**Framing:** Must meet Professional Standards. See specific requirements for applicable entry category on page 3. Refer to MasterWorks website or call category representative if in doubt.

**Wire:** *Must* peak at 3/2" below top of frame.

**No name plaques!**

**Labels:** Your name, Painting Title, Medium, and Price are to be on back of each painting.

**Repair Fees:** If the wire or frame needs to be adjusted or repaired when delivered to the venue, there will be a \$5 charge.

**Painting Title Limitation:** 25 characters, including spaces.

**Digital Specifications:** Digital file image must accurately represent the accepted painting, with no extraneous materials such as mats, frames or background showing in the image.

- **File Format:** JPG files only!
- **Image Resolution:** 300dpi
- **Image Size:** 1200 pixels on the longest dimension
- **File Name:** Rename image file to: Your Painting Title.jpg  
*Painting Title Limitation is 25 characters, including spaces.*

**Recommended software for adjusting Image size:**

Photoshop, Photoshop Elements, Lightroom, Preview, or other photo editing software. Look for Image Size or Adjust Size, then make necessary adjustments. Save as highest quality jpg file. *Additional information on creating a digital image is on the MasterWorks website.*

**Digital Image Usage:** MasterWorks maintains the right to use digital images of accepted works for promotional purposes.

**Liability:** Neither MasterWorks nor any sponsoring society, their officers or volunteers will be held responsible for loss or damage to any works.

**Biography:** Bring, or send, a one-page bio, which may include art experiences, contact information, art images and galleries, with your artwork. A copy may also be attached to back of accepted painting.

**Removal or Retrieval of Work:** No work may be removed before 9-11 am on Sunday, April 22, 2018.

**Non-Retrieved Work:** Paintings not retrieved by May 30, 2018 will be considered abandoned.

## OIL/ACRYLIC CATEGORY

Rio Grande Art Association

**MEMBERSHIP REQUIRED:** If you are not a member of RGAA, payment of the \$35 annual membership fee may be included with this entry, or through the RGAA website.

**Eligibility:** Two dimensional work, rectangular or square, must be in a painting medium or combination of media of oil, acrylic, classic egg tempera or encaustic not framed under glass and at least 80% of the surface must be hand painted. Sides of gallery wrapped canvases must be painted. Any relief elements used within the two dimensional work may extend or recede up to 3/4".

**Framing Requirements:** All accepted paintings must be framed or wrapped to gallery quality standards. No Glass or Plexiglas allowed in this category.

### MEMBERSHIP NOT REQUIRED

**Eligibility:** All work submitted must be at least 80% soft pastels.

**Framing Requirements:** All accepted works must be framed, with glass, to gallery quality standards. Glass should be standard glass, AR glass (anti-reflective), or museum glass. Non-glare glass is prohibited. Plexiglas is allowed, but discouraged.

**Mats:** Optional. If used, mats must be well cut and clean, with no debris between the glass and mat.

## WATERMEDIA CATEGORY

New Mexico Watercolor Society

### MEMBERSHIP NOT REQUIRED

**Eligibility:** All work submitted must be water-soluble media (excluding water-soluble oils) on cotton rag paper, cotton rag paper mounted on board, Yupo, watercolor canvas, Aquaboard, or oriental papers.

**IMPORTANT NOTE** - Only watercolors *not previously accepted/shown* in NMWS Spring and Fall Shows, WFWS Shows, or MasterWorks of NM can be submitted.

**Framing Requirements:** All accepted paintings must be framed to gallery quality standards with Plexiglas.

**Mats:** All accepted paintings must be matted with a clean and well cut mat. No color restrictions.

## Standard Fine Art Division Judge and Jurors



### Frank McCulloch, Judge

A recipient of the New Mexico Governor's Award in the Arts, UNM Distinguished Alumnus of the Year, Albuquerque Arts Alliance Bravos Award, MasterWorks Outstanding Achievement Award, and AABA "Local Treasure", McCulloch has works in collections including the National Hispanic Cultural Center, Museum of New

Mexico (Santa Fe), Museum of Albuquerque, UNM Museum of Fine Arts, and the Capital Art Collection at the State Capital Building in Santa Fe. He received his BFA from UNM and Masters from NM Highlands, both in Biology, and an MFA from Instituto Allende, Mexico. He taught high school art for 30 years, also served as visiting art faculty at UNM and Southern Methodist University. His legacy has been noted in Southwest Art Magazine, New Mexico Magazine, Art News, American Artist, and PBS Colores, to name a few. His style of work initially dealt with abstraction in the NM landscape, then became more simplified, with hard-edged geometric formalism, and now back to landscape through a variety of media.



### Jeanne Hyland, Juror

Ms. Hyland holds a BFA degree in figurative sculpture from University of New Hampshire and studied at École des Beaux Arts in France. Commercial design in Colorado preceded her return to Fine Art. She adopted watercolor after moving to California, where she taught at LA Academy of Figurative Art, Learning and Product Expos, Brand Library Studios. Now she teaches in

Santa Fe at Artisan's ARTSpot and Expos, and other locales nationally and internationally. Her works have been widely exhibited and have received many distinguished awards. Jeanne is a past Board Member, National Watercolor Society; Member of American, National, Southwestern Watercolor Societies, and Portrait Society of America; Signature Member of Watercolor West, Women Artists of the West and New Mexico Watercolor Society.



### Richard Alan Nichols, Juror

With a strong foundation in traditional impressionism, a tenure at the American Academy of Art in Chicago and tutelage under Irving Shapiro and Ted Smuskiewicz, Nichols has received numerous scholarships and awards. Calling Taos his source of inspiration, his works in oils, charcoal and watercolor reflect its landscapes with added interest in figurative

and still life works. Nichols is found internationally in permanent collections including the American Academy of Art, Taos Art Museum, Hughes and Koop Private Collections, the Universities of Wisconsin, Nebraska, Minnesota and Missouri, and many others. His exhibitions and awards include Oil Painters of America, Society of Master Impressionists, Nomadas Del Arte, Salon International. He has also been the poster artist for Taos Invites Taos.



### Dinah Worman, Juror

The work of award winning landscape painter Dinah Worman is instantly recognizable by its clarity and depth. Light is everywhere. It filters through the trees and streams and between the clouds.

After studying art at Colorado State University, University of Oklahoma and Metropolitan State University of Denver, a move to Sheridan, Wyoming

allowed her to work with William E. Wright for three years. This experience encouraged her to continually renew her vision, pressing beyond method into a flow of creative instinct. While Dinah's oil and pastel paintings are based on reality, the interpretation of the scene has become more important than the scene itself.

# Miniature Fine Art Division

**Definition:** Miniature Fine Art is fine art on a small scale with minute attention to detail which can sustain close inspection or magnification.

**Miniature Fine Art is juried and judged in its totality.** Jurors score the artwork on Framing/Presentation, Miniature Standards and Technique from actual artwork. No slides, photos, digital images, etc.

## Miniature Standards

**Accepted Media:** Acrylic, Colored Pencil, Drawing, Egg Tempera, Encaustic, Gouache, Graphite, Inks, Mixed Media, Oil, Painted Porcelain, Pastel, Prints (hand-pulled), Sculpture, Silverpoint and Watercolor. Collage is Mixed Media.

**Pricing:** All artwork must be for sale. Sale prices must be in increments of \$5, with *no work priced below \$95*.

**Scale:** Representational work is to be 1/6<sup>th</sup> or less of subject's actual size. Non-Representational work or a subject too small to portray at 1/6<sup>th</sup> scale must display a sense of miniature.

**Sculpture – 3D:** Entries must fit into a 3" x 3" footprint and be no taller than 6". All parts must be securely attached as a single unit.

**2-D Image Size:** Image area (height x width), 25 sq. in or less, including art that extends onto a mat or frame.

### Frames:

- All 2-D artwork must be framed.
- Frames must be gallery quality.
- Outer frame dimensions (h x w) not to exceed 56 sq. in.
- Frame moulding is to be no greater than 1 1/8" in width and 1" in depth.
- Frame moulding needs to reflect the essence of miniature.
- Liners will be considered mats.
- Glazing: artwork matted or on unsealed papers or Yupo must have glass or Plexiglas. Watercolors and Pastels that are stabilized with a sealant such as varnish do not need glazing.
- Backs of frames must be neatly covered.
- 2 D-rings or 2 small eye-screws must be attached for hanging. No saw-tooth hangers.
- Wire attachment is preferred.
- Bumpers should be placed at the lower back corners.
- No easel back frames are allowed.

**Mats:** Mats are optional for all media with no restriction on mat size or color. Mats must be of acid-free mat board, clean, neatly cut and proportional to the artwork. Liners are considered mats.

## Entry Procedure

**Number of Entries:** Up to 6 works of art per artist may be submitted. Maximum of 5 works per artist may be juried into show.

**Non-Refundable Entry Fees:** Paid upon delivery of artwork.

1-3 Entries = \$25	4 Entries = \$30
5 Entries = \$35	6 Entries = \$40

**Payment:** Cash; Checks (payable to Bardean LLC). No credit card payments accepted.

**ONLINE REGISTRATION REQUIRED:** Must be submitted and received by 5pm Saturday, March 10, 2018.

## Delivery & Retrieval of Artwork

**Packaging of Artwork:** All work must be packed in a single, sturdy, closeable, corrugated cardboard box. Each piece is to be wrapped in bubble wrap or placed in a padded envelope and secured with rubber bands to independently protect each piece. Do not use tape or styrofoam pellets.

**Labels:** Secure labels (provided on the following page) with tape to back of artwork. Number on label must correspond to entry number you provide on entry form.

**Biography:** When you deliver your artwork, submit a one-page statement of your art experience. You may also include gallery representation. Artists shipping artwork can include bio in box.

**Shipped Artwork:** Must be received by 5pm on Saturday, March 10, 2018. Include check for entry fee and return postage. No COD's accepted.

**Ship to:** Bardean LLC, PO Box 3055, Albuquerque, NM 87190-3055

**Hand Delivered:** Artwork and cash or check for entry fee are to be delivered Saturday, March 17, 2018 between 9-11am at the Hispanic Arts Gallery, Expo NM, 300 San Pedro NE, Albuquerque.

**Retrieval:** All unsold or unaccepted works may be picked-up on Sunday, April 22, 2018 from 9 - 11 am at the venue. Shipped work that was not sold or was unaccepted will be returned ASAP after the close of the show.

**Unclaimed Entries:** Works not retrieved by May 30, 2018 will be considered abandoned.

## Other Miniature Exhibition Details

**Notification:** All artists will receive phone call by Sunday, March 25, 2018 to notify them of acceptance/non-acceptance.

**Commission:** Division sponsor collects 40% of sale price and handles all applicable tax.

**Right of Refusal:** Bardean LLC reserves the right to refuse any work which fails to meet entry and eligibility requirements, including damage, improper framing or that which is deemed unsuitable for public viewing.

**Liability:** Neither Bardean LLC nor MasterWorks assumes any responsibility for loss or damages to works while in transit or in custody in connection with or during the show.

**Promotions:** Bardean LLC reserves the right to photograph any entry for publication in the Program Guide, publicity postcard, and newsletters, or in the news media. Artists are encouraged to keep a 300dpi digital image of their works.

### Necy Twinem, Judge



A fine artist, toy designer, academic professor and author/illustrator of over 32 children's books published in several languages. Twinem has been working as a professional illustrator, author and artist and instructor for over 24 years, as well as giving presentations at numerous school, libraries, conventions and conferences across the country. She launched her children's book career with her first title: *Aye-Ayes, Bears and Condors, An ABC of Endangered Animals and Their Babies*, published by Scientific American Books for Young Readers. Twinem's fine art is found in numerous private and public collections around the country. She has her Masters of Fine Art and instructs and mentors artists of all ages, at universities and beyond. Twinem developed a brand trademark titled, ZOMBIEZOO® including the design, manufacturing and release of a plush toy line and books, which has attracted international attention. Currently Twinem has partnered with Silo Media, Inc., to produce an animation series based on the ZOMBIEZOO® characters and content.



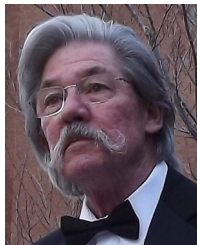
### Remy Rotenier, Juror

Paris-born and well-known jewelry designer and artist, Remy Rotenier is a third generation designer. He received his bachelor's degree in jewelry design in Paris while working for Cristofol, a workshop catering to the finest names in European high-end jewelry; a graduate gemologist degree from the French Institute of Gemology, passing a Diamond Grading with GIA, New York. He was hired by Tiffany & Co., NY, as one of three staff designers, later Kabana in New Mexico. Since 2006, Rotenier has directed Remy Design, taught at the Revere Academy in San Francisco, workshops at Wolf Designs in TN, and Creative Side in Austin, and has released 2 DVD sets. He has presented his creations on television, most recently as Jewelry Television's Remy Rotenier for Bella Luce. He has drawn and painted all his life, receiving 4 national awards and one international for miniatures and is a familiar MasterWorks artist.
