Paul Murray was elected a “Master Pastelist” in the Pastel Society of America this year, having won his third award in their show. The award winning painting, *Wetlands* won the New York Central Art Supply Award and was also selected to be exhibited with the “Best of the PSA Show” at the Butler Museum of Art in Ohio until Jan. 2010. Paul was also chosen as one of two Artists-in-Residence at the Grand Canyon for 2010.



He will be painting “below the rim” for three weeks in late summer. Paul also completed his selections as the Landscape Juror for the 2010 *Pastel Journal* Top 100 award. Paul also did an acrylic painting which is being held over in Boston for another exhibit which begins in April.



Vasili Katakis is pleased to announce that his painting, *Persephone*, will be part of a fabulous installation called “Albuquerque Now” at The Albuquerque Museum of Art & History celebrating the depth and diversity of our local artists. The exhibit opens Saturday, Jan. 23 at 7pm.

Jakki Kouffman, PSNM Signature Member, had her painting *High Desert, Cool Shade* juried into the first Biennale Grande (Jan. 29 - April 11, 2010) at the Hubbard Museum of the American West, located at 841 Hwy 70 West, Ruidoso Downs, NM. Kouffman was also invited to show eight of her paintings from Dec. 6 - March 6, 2010 in the “Faces and Places Show” at the New Mexico Cancer Center, located at 4901 Lang Ave in Albuquerque.

Susu Knight has a piece in the IAPS show at the City of Brea Gallery opening Jan 23rd. The Torrey Gallery in Torrey, Utah, just outside of Capitol Reef National Park now usually shows her work.

Terri Ford will serve as Judge of Awards at the 15th Annual International Association of Pastel Societies exhibit at the Brea Gallery. Her paintings *Sultry Dusk* and *Sonoma Shed* were both finalists in the *Pastel Journal*’s Pastel 100 Competition and will appear in the April 2010 issue. At the 1st Sierra Pastel Society Signature Members Exhibit, her painting *Placid Dusk* received 2nd place in the landscape category and tied for the Artist’s Choice Award. January Program Review

Paul Murray Demonstration

Anyone who views a Paul Murray pastel painting will agree that his work has drama, with strong contrasts, voluptuous color and sensuous texture. Everything Paul Murray paints is right on the mark. Why do his paintings hit target every time? We were lucky Paul made time in his busy schedule to show us the painting process that has worked so well for him and given him sure methods, disallowing any opportunity for failure. Paul is known for his landscapes, including a series of paintings he calls *Timepieces*, which he has been doing since 2006. These paintings have foregrounds in realism and “Technicolor”, imposed over backgrounds of grayscale or sepia. Check into your own memory bank of a meaningful event or place. We vividly recall the event or place in color, but we let the unimportant details in the background fade to gray. Today, Paul demonstrated the creation of a *Timepiece* for us, a scene from Plaza Blanca, also known as The White Place, near Abiquiu.

Paul brought in a masonite board he had prepared with a ground in his studio. After sanding the board to rough it up and sealing it, he texturized it with his own formula of extra heavy gel molding paste, black gesso, water and pumice. He puts on 3-4 coats of ground, letting each coat dry, before the board is satisfactory to paint. Because Paul puts a heavy ground on the board, he uses far less pastel to achieve interesting texture. He'll do a fairly detailed drawing on tissue, then transfer it onto the board using Saral transfer paper under his sketch. The Saral transfer adheres well and allows Paul to reapply some Saral lines over pastel if he accidentally covers up part of the drawing. Hard pastels are used for the underpainting, which Paul pushes into the rough ground texture with a “blending pad” he makes by removing one side of the paper removed from a small piece of black archival foamcore. The end result of using the foamcore as a tool, is a very smooth even surface. He playfully suggests that the archival foamcore is one of his “cheap tricks”! Paul uses hard pastels where he needs to blend and soft pastels where he needs colors to be distinctly defined. While applying pastel, he strives to place the darks and lights first, then goes back later with the mid-range values and detail. Though he prefers to *plein air* paint in early morning or late afternoon, the demo picture was based a photo of a mid-day scene. When discovering an area of the composition that needs more texture, or just needs to be painted over, he'll reapply some of his ground formula, which he has thinned with water, where he's going to repaint. After it dries (*he uses a hair dryer, another cheap trick*) it is

ready to receive more pastel. Some of Paul's finishing tips include “provide a visual pathway” to take the viewer deep into the picture, try replacing gray with a lavender of the right value, for a change, pinks are good soil colors in New Mexico, because we have several soil colors from the red family. He also told us how he makes new pastel sticks by grinding the small leftover bits of pastel he saves and mixing them with alcohol. Paul shares these very personal tips with us showing that he is very generous with his time and his techniques. For that we are ever grateful.

In 2009 Paul was very busy professionally, and it already appears that this year will be no different. He will have a few new opportunities this year that promise new challenges. He has been selected as a landscape juror for the 2010 Pastel Journal's Top 100, with the results published in the April issue. He will also be an artist-in-residence at the Grand Canyon in August.

PSNM definitely has a star in our midst. Not only is Paul a prolific artist, but he has a long list of awards and honors from around the country that are dazzling. And in addition to painting, Paul teaches *plein air* painting at Taos Art School and will also conduct a pastel workshop for the Santa Fe School of Art.
